APPROVAL OF MINUTES

Minutes from the November 22 meeting were approved.

TREASURER'S REPORT

- C.L. reported that the budget is on track.
 - o Cash balance is \$138,000.
 - He anticipates that we will use \$30,000-40,000 for the rest of the year, leaving a reserve of about \$100,000 for next year.
 - He paid the real estate taxes.
- Collection of dues was smooth this year, with everyone having paid so there was no need to file with small claims court.
- The Board conducted a local search for a firm to audit the club's financials, but the scope of the work is too limited to elicit interest for a one-time effort.
 - A community member is needed to lead an independent audit committee to search for an audit with an expenditure cap of \$4,000-5,000.
 - C.L. includes the bank statement with the financial reports, so reconciliation is straightforward.
