APPROVAL OF MINUTES

TREASURER'S REPORT

- C.L. reported that we net income is about \$20,000 ahead of budget due to having raised the dues.
- In June he will shift money into a new savings account
- Bill Vrooman volunteered to review SCC's financials. He has a degree in accounting and is the treasurer of his church.
 - o C.L will provide him the current financial reports and coordinate with him.
 - o Subsequent to the meeting: Bill will begin the audit when C.L. arrives on island.
 - Bill requests another community member who is comfortable with financial processes to assist him on this. Bill has worked with Quickbooks so that experience isn't necessary.

<u>Architectural Committee</u>

- Les reported that recently the signed covenants are not being returned to the Board after a closing. (When a Sengekontacket property is under contract, the Board sends the closing attorney a copy of SCC covenants for the buyers' signatures.)
- Two properties have recently closed:
 - 7 Mourning Dove (formerly Ute and Dieter Kuerschner)
 - Condominium 5 (formerly Carol Jackson)
 - We don't have any contact information for the new owners, so C.L. will find the court property records and Susan will send them a welcome letter via USPS to obtain their phone numbers and email addresses for the contact list.

Clubhouse

- Michael spoke with Linda Shaw. She is interested in again organizing community activities at the clubhouse. Linda will coordinate with Gail.
- The current clubhouse furniture as insufficient for large gatherings. Betsy will donate a table to go under the big windows in the back of the clubhouse. The Board agreed that no other furniture is needed at this time.
- Gail reported one member has reserved the clubhouse for mid-September.

Tennis Courts

- Gail has scheduled the courts to be power washed on May 10.
- Nets should not be put up before then.

Maintenance

- Tabor Tree removed several dead trees in the greenbelt area.
- The gravel portion of Sengekontacket Road has become very rough due to potholes from the construction at 41 Sengekontacket. Betsy will have Gordon fill the prominent holes with stones. The contractor has agreed to regrade the road in the spring when landscaping is complete.

NEW BUSINESS

Mailboxes

- Some garbage has been left behind the mailboxes. Betsy will ask Gordon to pick it up.
- Items should not be left on community property, and depending upon the item, should be brought to Oak Bluffs waste facilities, electronic/hazardous material drop-off at the high school that occurs twice yearly, or bagged and placed in home rubbish containers.
- The post office boxes need some maintenance. Les will talk to USPS. They are short of carriers so delivery is somewhat erratic.
